Sub: Release of Grants-in-aid to UT Govt. of Andaman & Nicobar under the Centrally Sponsored Scheme for Hospital & Dispensaries (under NRHM including AYUSH flexi-pool), 2012-13 - Reg.


Sir / Madam,

I am directed to convey the sanction of the President of India for the payment of Rs. 3,96,750.00 (Rupees Three Lakhs Ninety Six Thousand Seven Hundred Fifty Only) as Grants -in-aid - General to the State Health Society (AYUSH), UT Govt. of Andaman & Nicobar under the Centrally Sponsored Scheme for Hospital & Dispensaries (under NRHM including AYUSH flexi-pool), 2012-13) as Sanctioned recurring assistance for 16 PHCs, 3 CHC, 1 DH & 1 UHC for contingency of Rs. 2,35,000/- @ Rs. 10,000/- for each PHCs, @ Rs. 15,000/- for each CHCs, @ 20,000/- for DHs & @ Rs. 10,000/- for UHC, Rs. 50,000/- for Upgradation of 30 bedded AYUSH Hospitals & Rs. 2,44,000/- (Rs. 2,34,000/-for Salary of PMU & Rs. 10,000/- for Contingency) and to release Rs. 3,96,750/-(Rupees Three Lakhs Ninety Six Thousand Seven Hundred Fifty Only) as 75 % Central Government share for the implementation of the Scheme. The State Govt. shall ensure that 25 % of its share based on release of funds by GOI is credited to the State Health Society Account within one month of the release order. The details of Sanction Grants-in-aid and the purpose of grants are given below:-

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No. 10(1) PF-1/76 dated 22nd January, 1977 and as amended from time to time.
3. The Grant-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, and letter No. 2 (90) -P-II/66 dated 9.10.1966 and as amended from time to time.
4. The expenditure shall be incurred in respect of Plan heads of Accounts under the provision of GFR-2005/Receipts and Payments Rules 1983 and for the purpose for which it was sanctioned as clearly specified in para (1). Sanction has been issued as per rules 206 to 215 of GFR 2005.
5. The Grant-in-aid shall be subject to the conditions laid down in GFR-2005 and the instructions issued by the Government of India from time to time. The UT Govt. of Andaman & Nicobar shall not make any changes in allocation or re-appropriation amount different components / activities without approval of the Deptt. of AYUSH, MOH & FW, Govt. of India.
6. The UT Govt. of Andaman & Nicobar shall utilize the grants-in-aid and submit the actual Utilization Certificate of this grant within twelve months of the closure of the financial year in the prescribed **GFR19-A format** along with the **audited statement of accounts, expenditure statement, Achievement-cum-Performance Report** and Taxation shall be applicable as per Laws.
7. The assets acquired wholly or substantially out the Grants shall not be disposed off without obtaining the prior approval of the sanctioning authority.
8. It is certified that the amount of grant sanctioned above is within the budget provision accepted for the purpose by the Ministry of Finance for the financial year 2012-13. The funds released shall be utilized within 12 months from the date of issue of this sanction.
9. The accounts of the grantee institution/organization shall be open to inspection by the sanctioning authority and audit both by the CAG of India under the provision of CAG(DPC) act, 1971 and internal auditing of the O/o CCA of the ministry, whenever the institution or organization is called upon to do so.
10. The expenditure involved will be met from the funds provided under the Head: 2210- Medical and Public Health (Major Head); 02200—Other Systems (Minor head); 30- Hospitals & Dispensaries (Under NRHM including AYUSH flexipool); 300031-Grant for General interventions for recurring head under the Demand No.47-Department of AYUSH for the year 2012-13.
11. Essential drugs and medicines are to be procured from IMPCL (A Central Public Sector Undertaking) or from Public Sector undertakings, pharmacies and Co-operatives under the State Governments, who manufacture AYUSH medicines themselves in their own premises. The procurement of medicines is not permitted from loan license manufactures. (if applicable).
