**Subject: Release of Provisional Grants-in-aid to the Administration of the UT of Lakshadweep under the Modified Centrally Sponsored Scheme for Development of AYUSH Hospitals and Dispensaries, 2010-11 - reg.**

Sir,

I am directed to convey the sanction of the President for the provisional payment of **Rs.20,80,000/- (Rupees Twenty Lakh Eighty Thousand only)** as Grants-in-aid to the Administration of the UT of Lakshadweep under the Modified Centrally Sponsored Scheme for Development of AYUSH Hospitals and Dispensaries, 2010-11 **recurring assistance for establishment of AYUSH units at 2 CHCs @Rs.2.00 Lakh per unit , at 1 DH @Rs.3.00 Lakh per unit & at PMU Rs. 13.80 Lakh** and to release **Rs.12,85,000/- (Twelve lakh Eightyfive Thousand Only)** as 85% Central Government share for establishment of AYUSH IPDs and as well as 50% Central Government share for setting up of PMU for the implementation of the Scheme. The balance 15% share for establishment of AYUSH IPDs and 50% share for setting up of PMU shall be provided respectively by the State Government of Lakshadweep.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. Bo. 10(1) PF-1/76 dated 22<sup>nd</sup> January, 1977 and as amended from time to time.

3. The Grant-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No. 2 (90) –P-II/66 dated 9.10.1966 and as amended from time to time.

4. The expenditure shall be incurred in respect of Plan heads of Accounts under the provision of GFR-2005/DFPR-1978/Receipts and Payments Rules 1983 and for the purpose for which it was sanctioned as clearly specified in para (1) of above.

5. The Grant-in-aid shall be subject to the conditions laid down in GFR-2005 and the instructions issued by the Govt., from time to time.
6. The Grantee institution shall utilize the grants-in-aid and submit the actual Utilization Certificate of this grant within twelve months of the closure of the financial year in the prescribed GFR19-A format along with the expenditure statement in the prescribed format, audited statement of accounts, Achievement-cum-Performance Report and Taxation shall be applicable as per Law.
7. The assets acquired wholly or substantially out the Grants shall not be disposed of without obtaining the prior approval of the sanctioning authority.
8. It is certified that the amount of grant sanctioned above is within the budget provision accepted for the purpose by the Ministry of Finance for the financial year 2010-11. The funds released shall be utilized within 12 months from the date of issue of this sanction.
9. The accounts of the grantee institution/organization shall be open to inspection by the sanctioning authority and audit both by the CAG of India under the provision of CAG(DPC) act, 1971 and internal auditing of the O/o CCA of the ministry, whenever the institution or organization is called upon to do so.
10. The expenditure involved will be met from the funds provided under the Head: 2210-Medical and Public Health (Major Head); 02200—Other Systems (Minor head); 30-Development of AYUSH Hospitals & Dispensaries and Mainstreaming of AYUSH; 300031-Grant-in-aid-General for recurring head under the Demand No.47-Department of AYUSH for the year 2010-11.
