Sir,

It has been observed that there is a rising trend in Ayurvedic physicians to diagnose the patients on the basis of modern diagnostic and clinical methods and prescribe Ayurvedic medicines accordingly. The art of classical clinical diagnosis based on samhitas described in Ayurveda is disappearing. Many teachers as well as PG students of Ayurved have shown their interest in learning the art of Ayurvedic Diagnostic methods.

Hence, **Rashtriya Ayurveda Vidyapeeth, New Delhi** is proposing to hold a training programme for teachers of kayachikitsa, Rogavigyan and Panchakarma on "**Practical demonstration of samhita-based clinical methods of examination**" on **08-09 January, 2018** at **All India Institute of Ayurveda, New Delhi**.

In this connection, the Principals of the Ayurvedic colleges are requested to nominate two interested teachers of their college from any of the departments mentioned above for the said programme and send their application to RAV by email immediately. In view of limited seats the allotment would be on first-come-serve basis. Preference will be given to those colleges who have not attended earlier training programmes.

4. The resource persons invited for the programme would explain the complex Ayurvedic terminologies by elaborating their meaning and the method of their examination on patients. The resource persons would also demonstrate the disease diagnosis on the basis of samhitas and explain the clinical utility of samhitas.

5. All trainees will be provided modest accommodation and boarding. The Government teachers are entitled for reimbursement of 2nd AC train fare by shortest route.
