**Sub: Admission in Under Graduate and Post Graduate Courses in ASU&H College for academic session 2020-21-reg.**

Sir/Madam,

I am directed to refer to the subject cited above and to say that due to prevailing Covid-19 pandemic, Ministry has decided that the **last date/ cut-off date for admission in ASU&H Under Graduation and Post-graduate Courses will be 28<sup>th</sup> February, 2021** for academic year 2020-21.


2. Further, Ministry has also received various representations from AIAPGET-2020 aspirants regarding inability to complete their one year rotatory internship by 31<sup>st</sup> October, 2020 (last date for completing internship for eligibility for admission in ASU & H PG courses) due to Covid-19 pandemic and nationwide lockdown.

3. Ministry has examined this matter and decided to extend last date/cut-off date for completion of internship upto 31<sup>st</sup> December, 2020 for eligibility for admission in ASU & H PG courses for academic session 2020-21. However, such candidates who have applied for AIAPGET-2020 based on the existing criteria for completion of internship by 31<sup>st</sup> October, 2020 must have been started their one year compulsory rotatory internship on and before 1<sup>st</sup> November, 2019. Therefore, the starting date of internship for such candidates shall be on or before 1<sup>st</sup> November, 2019.

4. This clarification is applicable only for Academic Year 2020-21.

5. This issues with the approval of the competent authority.
