Sir,

In continuation to this Ministry letter of even number dated 16<sup>th</sup> December, 2020 on the subject noted above. I am directed to say that as per CGN guidelines dated 02.06.2020 the Central Government gives preference to regular teaching staff with 3 years' regular service of any **Government-run medical institution** for CGN. However, Dr. W.M.Sarfraz Nawaz is a Lecturer of Government Aided College i.e. not a Government-run medical institution. Therefore, the name of Dr. W.M. Sarfraz Nawaz, Andhra Pradesh mentioned as MO at serial No. 13 of the table in the said letter has been removed.
