**CORRIGENDUM**

Consequent upon Pre-Bid meeting held on 14.08.2014 in the Department of AYUSH in connection with EOI for appointment of Consultant/Project Management Consultant for preparation of DPR for establishment of All India Institute of Unani Medicine, Ghaziabad, decisions to make following modifications/ incorporations in the Expression of Interest were taken:-

1. On page no 3, in para 1.3, the word 'M.D' will be substituted by words 'MD/MS'.
2. On page no 3, in para 1.4, word 'M.D' will be substituted by words 'MD/MS'.
3. On page no 6, para 1.8, replace MD with MD/MS.
4. On page no 9, for "causality and ICU, IT Dept, Blood Bank, Ilaz Bit Tadbeer", insert the word 'Department of' before these words.
5. On page 10, the word 'Department of' will be inserted before Other Diagnostics.
6. On page 10, the word 'Department of' will be inserted before 'Maternity Center'.
7. On page 12 in para (vi), after the word signage the words 'included external signage & road markers' will be added, and after the words 'GRIHA', '(3 star Ratings)' will be added.
8. On page 12 in para (vii), in line 3 for the word 'excluding' may be read as 'including'.
9. On page 17 in para 2.8.2; cost estimating & financial services in sub-page (a) in line 3, after the word construction cost, and before 'and cash in use etc'; the following words will be inserted:  
'Statutory & third party certification costs'.
10. On page 37, after the para 'Submission of Expression of Interest' a new para will be inserted as follows:

- a. The bidder will deploy suitable WEB based project monitoring tools/software & facilitate remote log-in for the AYUSH project monitoring team. The log-in is to be password protected. If required, training for familiarization of the tool/software would be arranged for AYUSH project monitoring team.
  - b. Periodic reports (weekly/fortnightly/monthly/annual) would be submitted by the bidder to report on the progress of the project. Format and type of the report would be shared with the successful bidder prior to the commencement of the contract.
11. On page 39, after para 'e' a new para (f) is to be added:  
 '(f). The bid will not stand rejected in case of inadvertent usages of previous version of EOI notified on 08 August 2014".
12. On page 53, 'Form E' will be substituted as:
