1. Introduction

- 1.1. AYUSH Centre of Excellence (ACE) programme will be implemented by Ministry of AYUSH to recognise the organisations which have demonstrated excellence on a wide range of areas including Research and Drug Development in Ayurveda, Yoga & Naturopathy, Unani, Siddha and Homoeopathy (AYUSH). Organisations with exceptional contribution at National and International level are considered for conferring the ACE Programme as recognition for their substantial contribution in the field of AYUSH services. Medical and health care organisations from other discipline having extraordinary work in AYUSH are also eligible under this programme. An organisation can apply for any branch, department or workgroup under their domain. This programme will not provide any financial assistance from Government of India.
- 1.2. Through this recognition, the distinctive and exemplary contributions of these organisations will get wider publicity and acceptance. Such organisations will in turn become a part of various activities in collaboration with the Ministry.
- 1.3. This programme will not have any claim under the Central Sector Scheme for assistance to AYUSH organisations for upgradation to Centres of Excellence.

2. Objective of 'AYUSH Centre of Excellence' Programme

The purpose of awarding 'AYUSH Centre of Excellence' program is:

- ✓ to create a network of organisations that will accelerate research in AYUSH systems.
- ✓ as recognition to the organisations for their substantial contributions in the field of AYUSH research/activities.
- ✓ to encourage organisations having synergy in different areas to work on key emerging areas such as training, research and other services in AYUSH.
- ✓ to recognise the organisations, conducting high quantity AYUSH research, especially those involving international collaboration with reputed institutions, and meet international standards in providing quality health services.
- ✓ to undertake specific projects/deliverables within a stipulated period in collaboration with Ministry

3. Validity

- 3.1. Initially, Ministry will be considering the programme for three years from date of notification and put up for revision thereafter.

4. Areas covered

4.1. The following organisation models are considered for the ‘AYUSH Centre of Excellence (ACE)’ programme:

- i. Centre of Excellence in AYUSH Research
- ii. Centre of Excellence in AYUSH Health Services
- iii. Centre of Excellence in AYUSH multispecialty services
- iv. Centre of Excellence in AYUSH Pharmacology/Pharmacognosy
- v. Centre of Excellence in AYUSH Pharmaceutics
- vi. Centre of Excellence in Ayurved Biology
- vii. Centre of Excellence in Medicinal Plants

5. Eligibility

5.1. General Instructions:

- i. Institutions having a track record of at least five years of meritorious work in the AYUSH sector, specifically in the proposed activity, with a proven record of Excellence
- ii. Institutions having necessary evidence for their potential for achieving a level of eminence in the respective fields at State level /National/International level.
- iii. Constituent part / Department of an institution is also eligible for this programme
- iv. Institutions having track records of meritorious accomplishments during the last five years in the category of application and having prestigious/notable National and International awards in the field
- v. Institutions possessing adequate infrastructure in terms of building & equipment as per Minimum Standard Requirements of Ayurveda Colleges and attached Hospitals
- vi. Institutions having a team of competent staff working in the areas for which it is applied
- vii. Institutions should have published Annual Report and Audited Statement for last 03 years
- viii. Institutions black listed / having pending projects under Ministry will not be eligible

5.2. Government organisations:

- i. Government aided Institutions/ Undertaking/ Universities/ Research Councils/ Autonomous Organizations engaged in one or more areas/aspects of AYUSH health care
- ii. Government owned Universities declared under University Grants Commission Act and colleges affiliated to University with permission continuously for 05 years from Ministry of AYUSH
- iii. Institutions having a Governing Body and Management Committees (Scientific Advisory and Ethical) with reputed experts having experience in AYUSH systems

6. Procedures for applying ‘AYUSH Centre of Excellence (ACE)programme

- 6.1. Applications for AYUSH Centre of Excellence (ACE) Programme shall be made in the prescribed Proforma[**Form A & Form B 1-8** (as per the category in which application is submitted)]
- 6.2. The Organisations should submit their detail research proposal relevant to the field of proposed excellence along with the clear objectives, rationale, methodology, timeline, deliverables/outcomes of the program .
- 6.3. Two sets of application signed by the head of the Organisation/authorised person with Seal of Office are required to be submitted in the Ministry along with the documents. Photocopies of the documents should be readable. Documents in the regional language should be translated to English/Hindi.
- 6.4. In case of Non-Governmental organization, the proposal should be forwarded & recommended by the State AYUSH Directorate, not below the rank of Director.
- 6.5. Application (**Form A & Form B 1-8 as applicable**) may enclose:
 - Concept note on the current AYUSH activities as per the eligibility criteria for applying ‘AYUSH Centre of Excellence’ programme
 - Vision document on the proposed research project (including background, rationale, methodology, duration, plan of action for 03 years and deliverables)
 - Details of the research project in relevant field with well-defined deliverables
 - Documentary evidences for year of establishment
 - Composition of Management Committee (details of members, designation address, e-mail ids, contact number, letter of acceptance)
 - Objectives of organisation & details of activities supporting the previous track record as an eminent institute in corresponding field with supporting documents
 - Major achievements, research work, meritorious accomplishments during last 05 years & documentary evidences
 - Profile of available staff (details of designation, email ids, contact numbers & copy of letter of acceptance) and infrastructure (details of facilities, equipment-year of purchase, cost of equipment)

7. Review of the status of ‘AYUSH Centre of Excellence’ programme

- 7.1. Ministry will decide a time-line for the completion of this programme and conduct periodical review of the progress.
- 7.2. The recognition may be initially granted for a period of three years. The status of ‘AYUSH Centre of Excellence is liable to be derecognized at any time as deemed by the PSC for ACE Programme.

8. Selection process

- 8.1. The applications will be scrutinized quarterly. Applications received in each quarter will be processed in the preceding month.
- 8.2. The selection will depend on the relevance of the project in broader aspect and its significance to current to priorities of the area of specialization. Proposals could be required to connect to the Committees for the approval. The Committee may suggest modifications in the proposal for collaboration.
- 8.3. Ministry of AYUSH will examine the merits of the proposals before according the status of ‘AYUSH Centre of Excellence’. After initial scrutiny, Programme Appraisal Committee (PAC) and Programme Sanctioning Committee constituted by this Ministry will examine the merits of the proposals.
- 8.4. The applicant organisations will be invited for undertaking specific projects/deliverables before PAC.

9. Deliverables

- 9.1. The deliverables submitted along with the application will be examined under respective Research Councils/statutory bodies of this Ministry and recommendations will be placed before PAC for ACE Programme.
- 9.2. Each organization has their own unique deliverables. Some of the model deliverables for each category is as follows:
