**NOTE :**

(i) Coordination is clubbed with Parliament & RTI Section. Coordination, Parliament & RTI Section (CP & RTI section) will be under JS (DSP) wing.

(ii) Sh. Vikram Singh, Director will report to SS through Advisor (ATG) for matters pertaining to IMPCL.

(iii) Files relating to Technical matters of Ayurveda / Sowa-Rigpa / Folk Medicine in concerned (National Institutes / Resesarch Councils) will be routed through Advisor (MN) and submitted to the respective Wing Head.

(iv) All administrative and Technical matters of Homoeopathy concerned (National Institutes / Resesarch Councils) will be routed through Dr Sangeeta Duggal, Adviser (H) and financial sanctions in respect of Homoeopathy section will be signed by US (AB).

(v) Files relating to Technical matters of Unani in concerned (National Institutes / Resesarch Councils) will be routed through Advisor (Unani) and submitted to the respective Wing Head. US (MLM) will sign the financial sanctions and matters related to court cases pertaining to Unani in Siddha & Unani section.

(vi) The work related to Pradhan Mantri Jan Arogya Yojana (PM - JAY) will be looked after by the Drug Policy Section.

(vii) Financial sanctions and Court matters for AEP-II will be signed by US (S) and for AEP-III will be signed by US (MLM).

(viii) Financial Sanctions in respect of DPS and AYUSH Grid will be signed by US (KBS).

(ix) Budget matters of Ayurveda, Siddha, Unani, Homoeopathy and Y&N sections will be coordinated by JA (Q).

(x) The files relating to CME and PHI schemes (technical matters) will continue to be routed by Dir (VS) through Adv (MN) to the wing Head. Files relating to EMR scheme (technical matter) will be routed by Dir (VS) through Adv (ATG) to the wing head.
