Sir,

I am directed to refer to your Letter No. A.12025/06/2018-E.I (AYUSH) dated 11.11.2019 (received in the Commission Office on 13.11.2019) forwarding therewith the requisition for recruitment to the above mentioned posts.

2. Of the 37 Posts of Medical Officer/Research Officer (Ayurveda) in Ministry of AYUSH, advertised vide Advt. No. 02/2020 (Item No. 01, Vacancy No. 20010201125) dated 25.01.2020, 05 posts are reserved for SC, 03 posts are reserved for ST, 03 posts are reserved for EWS, 10 posts are reserved for OBC and remaining 16 posts are Unreserved. Of the thirty seven vacancies, one vacancy is reserved for Physically Challenged person viz. Locomotor Disability including Cerebral Palsy, Leprosy Cured, Dwarfism, Acid Attack Victims and Muscular Dystrophy with disability i.e. One leg affected (R or L) (OL) or One arm affected (R or L) (OA). The posts are also suitable for Physically Challenged person viz. Locomotor Disability including Cerebral Palsy/ Leprosy Cured/ Dwarfism/ Acid Attack Victims/ Muscular Dystrophy with disability i.e. One leg affected (R or L) (OL) or One arm affected (R or L) (OA) or Leprosy Cured (LC) or Dwarfism (DW) or Acid Attack Victims (AAV) or Muscular Dystrophy (MDy).

3. Since the number of applications received was large, a Computer Based Recruitment Test was conducted by the Commission on 20.12.2020 to shortlist the number of candidates to be called for interview. On the basis of result of Computer Based Recruitment Test declared on 22.01.2021, 125 candidates were shortlisted. After scrutiny of documents/applications furnished by the candidates, 104 candidates were found eligible and called for interview. The interviews were held from 13.12.2021 to 16.12.2021.

4. On the basis of the results of the Computer Based Recruitment Test and interviews, the Commission recommended 37 candidates [05 SC, 03 ST, 05 EWS (including 02 EWS Recommended against Unreserved Vacancy), 14 OBC (including 04 OBC Recommended against Unreserved Vacancy & 01 PH) & 10 UR] as per Annexure to this letter on an initial pay as indicated therein for appointment to the post of Medical Officer/Research Officer (Ayurveda) in Ministry of AYUSH in the Pay Scale of Level 10 in the Pay Matrix as per 7th CPC.

5.(a) The candidate bearing Roll No. 0023753 (OBC), 0020607 (EWS), 0024824 (OBC), 0022102 (OBC), 0024613 (OBC) & 0020383 (EWS) have been recommended against Unreserved Vacancies.

(b) The candidate bearing Roll No. 0021263 (OBC) has been recommended Three Months Training.

(c) The candidate bearing Roll No. 0022382 (OBC/PH) has been recommended Six Months Training.

6. The candidates called for interview were required to bring with them the original certificates, copies of which were submitted by them in support of their date of birth, educational qualifications, caste certificates etc. The certificates were checked at the time of their interview. However, the Department/Ministry is also requested to thoroughly verify the veracity of these certificates again before offering appointment to these candidates.

7. A Reserve Panel of candidates has been kept in this case. The validity period of Reserve List will be two (02) years from the date of finalization of the Recommendation of the Commission i.e. 24.12.2021. In case the selected candidate after giving a reasonable time to join against the selected post does not join, Ministry of AYUSH may request the Commission for release of a name from the Reserve List after cancellation of the offer of appointment of the selected candidate.

8. In Annexure to this letter, Sl No. 27, 28, 32, 33 & 34 claimed to belong to SC Community, Sl. Nos. 31, 35 & 36 claimed to belong to ST Community, Sl. Nos. 4, 16, 26, 29 & 30 claimed to belong to EWS and Sl. Nos. 1, 7, 8, 10, 17, 18, 19, 20, 21, 22, 23, 24, 25 & 37 claimed to belong to Other Backward Classes Community not coming under the creamy layer status as per the DOP&T O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993 and modified vide Govt. of India DOP&T OM No. 36033/3/2004-Estt. (Res) dated 09.03.2004 & DOP&T O.M. No. 36033/3/2004-Estt. (Res) dated 14.10.2008. Their claims to belong to these communities have been provisionally accepted on the basis of the original Certificate submitted by them at the time of their interview. A copy of these Certificates can be seen in their application dossier. The Government should verify further the veracity of the documents before issuing offer of appointment to the candidate. In the case of issuing offer of appointment provisionally pending verification of the veracity of these documents, the instructions as contained in DOP&T O.M. No. 36012/6/88-Estt.(SCT)(SRD III) and O.M. No. 36033/9/95-Estt.(SCT) dated 24.4.90 and 10.5.95, respectively, should be followed.

9. The candidates named in Annexure have not been medically examined for these posts and no special enquiry into their antecedents has been made. I am to forward herewith their application dossiers with enclosures, which may kindly be retained by you on their appointment as part of their personal files. I am also to forward herewith their Attestation Forms. Two copies of their photographs have been attached with the Attestation Form and the third copy has been attached with their applications. Third copy of their photographs may be retained by the Government as office copy, vide para 1(d) of the Ministry of Home Affairs O.M. No. 3/3/(S)/68- Estt. B dated the 11th August, 1969.
