Subject: Recruitment to 07 (SC-01, ST-01, OBC-02, EWS-01 & UR-02) posts of Medical Officer/Research Officer (Unani) in the Ministry of AYUSH, GoI, New Delhi (Vacancy No : 20010202125).

Sir,

I am directed to refer to your letter No. A. 12025/06/2018-E-I (AYUSH) dated 06/13 November, 2019. The Union Public Service Commission received a requisition for Recruitment to 07 (SC-01, ST-01, OBC-02, EWS-01 & UR-02) posts of Medical Officer/Research Officer (Unani) in the Ministry of AYUSH, GoI, New Delhi on 13/11/2019. The Commission advertised the post, vide Advt. No. 02/2020, Item No. 02 of 2020 (Vacancy No. 20010202125) on 25/01/2020. In response to the said advertisement only 606 (SC-23, UR-280, ST-08, EWS-14 & OBC-281) applications were received. The Commission considered the applications of UR and OBC candidates, therefore, criterion for these two category has been enhanced in order to restrict the number of candidates for these two categories. and accordingly called 54 (UR-23, ST-05, SC-07 & OBC-19) candidates, who were found suitable for interview on 31st, January, 2022 & 01 to 03 February 2022. Out of them, 39 (ST-05, SC-04, OBC-13 & UR-17) candidate was interviewed and the others failed to appear before the Interview Board.

2. The Commission has recommended 06 (UR-01, OBC/CL-01, OBC-02, SC-01 & ST-01) candidates based on the interview as per Annexure 'A' to this letter on an initial pay as indicated therein for appointment to the posts Medical Officer/Research Officer (Unani) in in the Ministry of AYUSH, GoI, New Delhi.

3. **Reserve Panel.** As per IBR finalized, 08 candidates have been kept in Reserve Panel, which is valid for a period of 2 years from the date of finalization of the IBR (Interview Board Report) dated 08 February 2022. In case the selected candidate does not join after being given a reasonable time, you may request the Commission for release of a name from the Reserve Panel after cancellation of the offer of appointment of the selected candidate. The Reserve Panel will become null and void on finalization of selection for filling up subsequent vacancies in the same grade.



4. **Infructuous** The recruitment action to fill up of EWS-01 post has become infructuous at scrutiny stage. It is therefore, suggested that Ministry may examine the matter at present stage and if the vacancy still exists and falls under direct recruitment quota; a fresh requisition may be forwarded to the Commission after reviewing the reservation position for making another attempt for recruitment.

5. **Verification of Degree/Diploma** of The candidates called for interviews were required to bring along with them the originals of (i) the Degree/Diploma certificates or other certificates in support of their qualifications and (ii) Matriculation or equivalent certificates in support of the date of birth claimed by them. The original Certificates and rest of requisite all Degree/Diploma etc may kindly be verified before their appointment.

6. **SC/ST/OBC Communities.** The Candidates at Serial No. 03 to 06 in Annexure 'A' have claimed to belong to **SC/ST/OBC Community**. Their claims to belong to their community have been provisionally accepted on the basis of the original certificates submitted by them at the time of interview. Copy of these certificates can be seen in their respective application dossier. As instances have occurred where candidates obtained and produced **SC/ST/OBC** certificates even though they did not really belong to this category, you may, therefore, verify further veracity of these documents before issuing offer of appointment to the candidates. In case of issuing offer of appointment provisionally pending verification of the veracity of this document, the instructions as contained in the Department of Personnel & Training O.M. No. 36012/6/88-Estt. (SCT) (SRD-III) and O.M. No. 36033/9/93-Estt. (SCT) dated 24.04.1990 and 10-05-1995 and 36033/4/97-Estt.(Res.) dated 25-07-2003 respectively should be followed.

7. **Medical.** The recommended candidates have not been medically examined for this post and no special enquiry into their antecedents has been made. I am forwarding their applications with enclosures, which may kindly be retained by you on their appointment as part of their personal files. I am also to forward his Attestation Forms. Two copies of photographs of each of candidate have been attached with the Attestation Form and the third copy has been attached to their applications. Third copies of photographs may be retained by you as office copy, vide para 1 (d) of the Ministry of Home Affairs O.M. No. 3/3/(S)/68-Estt.(B) dated the 11th August, 1969. Copies of the offer of appointment letters to be issued to them may be endorsed to the Commission. The Commission may also be informed as soon as the Candidate joins duty.



8. **Offer/appointment letter** In this connection, attention is invited to the Department of Personnel & Training OM No. 39011/06/2012-Estt. (B), regarding elimination of delays in issuing offers of appointment to the candidates joining the post in question. **Accordingly, it may be ensured that offer of appointment is issued to the candidates within three months from the date of issue of the Recommendation letter and copy of offer/appointment letter be endorsed to the Commission.**

9. **Documentations** The documents in support of Essential qualifications, experience certificate(s) and Matriculation or equivalent certificates in support of date of birth, Community certificates etc have been checked by the Commission and their claims have been accepted on the basis of the original certificates submitted by them at the time of interview. Copies of these certificates can be seen in their respective application dossier. You may, however, further verify the veracity of their documents before issuing the offer of appointment to the candidates.

10. I am also to add that the number and date of this letter may invariably be quoted in all future correspondence especially while forwarding offers of appointments/while sending intimations regarding the candidates joining the posts in question.
